**Cash Buyers:**  
 If you do not intend to license or operate until a seasonal crop is available, please submit the enclosed Affidavit of Non-operation with your renewal application when you do license. No penalty will be assessed as long as a license is secured BEFORE operations have begun.

**Note:** If you are licensed in more than one category, the first license fee is \$560.00 and \$25.00 for each additional license. Please explain on the reverse side if a change has been made in the operation or structure of this firm during the past year.

Checks returned by the bank will be charged a handling fee of \$25.00. (RCW 62A.3.515 (a) and 62A.3.520)
